Communications Received - Al

Four emails were received at Council's public email address, all from Steve Free.

- Steve suggested that we celebrate the birthday of Marion McDonald, who just turned 99, and who is one of the few remaining charter members of KUC. She was acknowledged in church before Christmas, and Pastoral Care is sending a card.
- He thanked all involved in the first Visioning and Renewal Workshop and requested a copy of Cindy's sermon preached that day. - The sermon is available, in context, in the recording of the service, on our YouTube channel @kuclive.
- He expressed interest in participating in the EOORC celebrations for the 100th anniversary of the United Church of Canada. - Cindy is chairing that celebration, and there will be much more about it in church.
- He hopes to learn soon what will be covered in the remaining two visioning workshops. - Our facilitator's process is to base the second and third workshops on our congregational input during the first workshop. We invite all to come to the remaining two workshops and participate as they unfold.

Minister's Update - Cindy

- Aleesha Katari, a student who has practiced at KUC for years, will be filling in as organist until April. Nick is helping to provide leads for a permanent replacement.
- Nick will be out of town Feb. 2 but returns for his last Sunday Feb. 9, which will have a celebration of his time with us.
- Cindy will also be away Feb. 2 to attend a friend's funeral in Nova Scotia. Mary our workshop facilitator will lead worship that day, proceeding into the workshop.
- Tickle Trunk sale coming up (donation and purchase of kids' clothing). Tickets will go to two women's shelters.
- Christmas services went very well with many new faces in the congregation.
- A woman, not a member, has offered to create a team to update our front garden. There are also several volunteers from the stewardship forms.
- Centre 33 has a new projector that works well, and we will try it for the AGM. We may buy the same kind from our Seniors' grant.
- Worship has recommended that we install a permanent ramp to the raised level of the sanctuary. Looking at designs, and grants to support this.
- Given Donald Trump's attack on gender diversity, which may raise echoes in Canada, we are planning to host a gathering to support Centre 33.

Revised AGM Agenda - Julia

Discussion of whether we should continue to hold the AGM as a hybrid event online and in person. Council agreed to return to an in-person-only AGM, with a light snack after the service. We will try to achieve a timeline of 90 minutes. New procedures to keep the meeting moving should help.

Financial Update - Kathy

Draft budget was circulated. Some adjustments are still to be made, especially treating the sabbatical expenses properly as an amount to be paid into reserves each year then spent when the time comes. Other changes will correct things that were wrong before, including some that should have been in the budget that was approved last year. In particular, we should have shown a small budget deficit for 2024. See notes at the end of this draft budget. This is being worked out with the accountants who are preparing our financial statement (pro bono again!).

The loss of two key staff members (Michelle and Nick) will reduce expenses until replacements are found but that is not good news.

We need to ensure that our budget each year reflects what we believe we will need, whether or not it is similar to past years. Things are likely to change according to changing circumstances, on both revenue and expense sides. We should show a budget deficit based on full staff, even if for a few months we are spending less, because that will keep us focused on the real cost of what we are trying to do.

Growth Journey Update - Cindy

- Review of Grant Spotlight Slides there is potential for new grants but they can
 only be shown if and when they are approved. This is another exciting aspect of our
 growth, which is exceptional among UCC congregations.
- Review of Stewardship Spotlight Campaigns have been successful. Significant growth in pledges and PAR, and continuing arrival of new members including 5 new choir members. All of that is good news.
